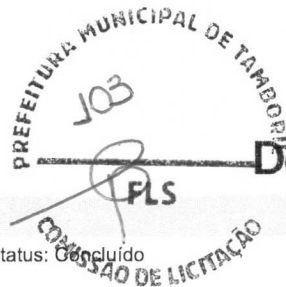

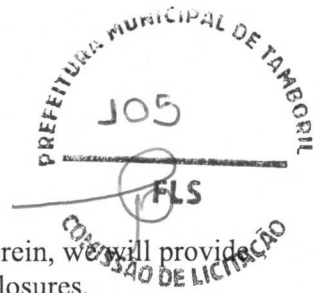
Withdrawing your consent

Consequences of changing your mind
